SUMMARY

Mr. Brophy is a managing director in Berkeley Research Group's Forensic and Litigation Consulting segment and is based in New York. He is a Certified Public Accountant with over twenty years' experience assisting policyholders with complex insurance claims and other damages matters. This has included property damage and business interruption claims resulting from catastrophic losses such as the September 11, 2001 terrorist attacks, hurricane losses, earthquake losses, and numerous individual matters.

He has prepared claims and damage assessments in nearly all industries, including manufacturing, chemical, oil and gas, hospitality, retail, health-care, financial services and non-profit.

In addition, Mr. Brophy has managed several forensic investigations, assisted clients with contract disputes, and managed the recovery of fidelity claims. He has testified on several insurance related matters. He is a Certified Appraiser and a Certified Umpire in the Insurance Appraisal and Umpire Association (IAUA).

Mr. Brophy previously held senior management positions at other international consulting firms.
